Jeff motioned to accept the awards and Denise provided a second. High point categories include halter, 10 & under, 13 & under, 14 – 17, 18-34, 35 & over, Open, Reining, Ranch Riding, Lead Line. Linda motioned to break up walk/jog in to separate categories and Rhonda provided a second. The club passed the motion. Denise then motioned to have a separate Youth W/J highpoint and an Adult W/J highpoint and Sue provided the second. The club voted and passed the motion. The Youth/Amateur W/J categories will include showmanship classes. W/J points cannot cross over and exhibitors will need to declare which highpoint they are going for at the time of registration. Sherry has secured Johnny Carmonas as our food vender and they will be at the fairgrounds 8am through lunch. Members discussed have a drawing/raffle to give away our left over awards. We will use back numbers and winners will be pulled at random. Premium review will be finalized at our June 6th meeting with mailing immediately following once approved for distribution.

No other old/new business was discussed so Rhonda made a motion to adjourn the meeting with Sue provided the second.
