Denise brought a sample copy of our show "Save the Date Card" and it looks awesome. Denise will have the final cards printed and begin mailing out next week. Our show premiums will go out within the next two weeks as well!

We have secured local business owner Renee Carrillo and her GVA Café Catering business as our food vendor for all three shows at Bolado Park. A few of our club members will make another run to Bolado Park to check in with Fairgrounds Staff and make sure we are all set for our first show on 4/18. Sue is inquiring about horse show software for the club to purchase prior to the first show.
